



HumanRights360 is a non-profit organization established in October 2017.

HumanRights360's headquarters is located in the Municipality of Athens and it is registered in the General Commercial Register with Registration No (G.E.MI.) 143978901000.

The statutory object of HumanRights360 is the advocacy of human rights, the education and raising awareness of society on the human rights and values, the revelation and propagation of the ancient and modern Greek civilization in Greece and abroad, the restoration and renovation of buildings, historic and other, through creating a network of integrated services and jobs, the pursuit of the collective welfare through enhancing, supporting and promoting the integration of persons or social groups of the population which belong to vulnerable groups regardless of origin, religion, gender, sexual orientation and gender identity, race, age, ethnic origin, physical integrity, as well, and the promotion of these values in order to raise awareness of society.

Ourania (Rania) Papadopoulou, an active member of civil society during the last 10 and more years with an extensive experience in this field has been appointed as organization's administrator and representative.

The organization is governed by the General Assembly, the General Director, and Administrator and the Advisory Board.

The General Assembly constitutes the supreme body of the organization, consists of all members of the organization, and decides on all issues and activities of the organization, convened ordinarily once a year, within the first trimester of that year, and extraordinarily upon request by any of its members and/or the Administrator. The General Assembly is responsible to determine the strategy and policy of the organization and sets also the objectives to be achieved.

The General Director is appointed upon an unanimous decision of the General Assembly. His responsibilities are to direct the organization's activities, to ensure for the achievement of the organization's objectives, as they may have been determined by the General Assembly, to proceed to the right planning of programmes and activities, to monitor and oversee the implementation of the programmes, to manage public relations and communications with donors, sponsors, public and private agencies, institutions, foundations, in Greece and abroad, to contribute to public awareness with respect to human rights and to find resources for the organization, as well as to the coordination, cooperation and use of the organization's staff.

The Administrator is appointed by the General Assembly and, with the exception of the issues for which the General Assembly is competent according to law and the Articles of Association, manages the organization's affairs, and represents solely the organization before all Courts and Authorities, before all natural and legal persons public or private, whether Greek or foreign, before the Greek or foreign State, before all Greek and foreign banks, in or out of court, acting in the name and on behalf of the

organization all acts that pertain to the organization's administration, the management of its assets and the pursuit of its objectives in general.

The organization's Advisory Board consists of 2-7 members elected by the General Assembly with a term of office of one (1) year and the right of reelection. The members of the Advisory Board are persons who bring specialized knowledge and skills and can enhance the administration of the organization by providing recommendations, information, skills or resources for special work in basic sectors of actions which are not covered by the organization's staff. The Advisory Board provides advice, assists in building relationships with regard to charity by the regular exchange of ideas, technical assistance, assessing the impact of the programmes under planning and/or implementation as well as by finding balanced, impartial answers for important projects and assisting in the expansion of the organization's range by creating networks and contacts in civil society and contributing to the finding of new prospects, always within the organization's object. At the same time, the Advisory Board sees to the on-the-spot guidance of the partnership in sectors such as fund raising and event planning, which can constitute essential tools for the optimization of the organization's work. The Advisory Board holds a meeting at least once per three months, and its members do not receive any remuneration.

The goal of Human Rights360 is the promotion and enhancement of the European values and the universal ideals of culture, democracy, social solidarity, as well as the raising of awareness to citizens on these values and ideals.
